Summary for Audit Committee

This Annual Audit Letter summarises the outcome from our audit work at West Yorkshire Fire and Rescue Authority ("the Authority") in relation to the 2017-18 audit year.

Although it is addressed to Members of the Authority, it is also intended to communicate these key messages to key external stakeholders, including members of the public, and will be placed on the Authority's website.

Audit opinion

We issued an unqualified opinion on the Authority's financial statements on 1 August 2018. This means that we believe the financial statements give a true and fair view of the financial position of the Authority and of its expenditure and income for the year.

Financial statements audit

Our audit procedures are designed to identify misstatements which are material to our opinion on the financial statements as a whole. Materiality for the Authority's accounts was set at £1.1 million which equated around 1.8% percent of gross expenditure. We designed our procedures to detect errors in specific accounts at a lower level of precision.

We report to the Audit Committee any misstatements of lesser amounts, other than those that are "clearly trivial", to the extent that these are identified by our audit work. In the context of the Authority, an individual difference is considered to be clearly trivial if it is less than £0.05 million for the Authority.

We identified one adjusted audit difference with a total value of £1.01 million (see below). This adjustment did not impact the reported deficit on provision of services.

Our audit work was designed to specifically address the following significant risks:

- Valuation of PPE We considered the way in which the Authority gains assurance that the valuation of assets does not differ materially from their last valuation. We found the Authority was able to demonstrate there is no material difference through their annual impairment review of all properties and application of market indices to those assets which have not been subject to any enhancements since their last valuation;
- Pensions Liabilities We have reviewed the processes in place to ensure accuracy of data provided to the Actuaries for both LGPS and FFPS schemes and considered the assumptions used in determining the valuation. Overall we have been able to conclude the data is complete and accurate and the assumptions used by the Actuaries are reasonable with the exception of the estimated investment return for the LGPS pension asset valuation. This required replacement of the estimated investment return with the actual. This has resulted in a material adjustment to the net pension liability of £1.01m. This adjustment had a nil impact on the reported deficit on provision of services; and
- Faster Close The timetable for the production of the financial statements has been significantly advanced with draft accounts having to be prepared by 31 May (2017: 30 June) and the final accounts signed by 31 July (2017: 30 September). We worked with the Authority to understand the steps being taken to meet these deadlines and the impact on our work. We were pleased to report that the Authority met the deadline for submission of the draft accounts. The deadline for the final accounts was missed by one day, due to the Authority awaiting the revised LGPS asset valuation from the actuary.

Other information accompanying the financial statements

Whilst not explicitly covered by our audit opinion, we review other information that accompanies the financial statements to consider its material consistency with the audited accounts. This year we reviewed the Annual Governance Statement and Narrative Report. We concluded that they were consistent with our understanding and did not identify any issues.

Whole of Government Accounts

The Authority prepares a consolidation pack to support the production of Whole of Government Accounts by HM Treasury. We are not required to review your pack in detail as the Authority falls below the threshold where an audit is required. As required by the guidance we have confirmed this with the National Audit Office.

Value for Money conclusion

We issued an unqualified conclusion on the Authority's arrangements to secure value for money (VFM conclusion) for 2017-18 on 1 August 2018. This means we are satisfied that during the year the Authority had appropriate arrangements for securing economy, efficiency and effectiveness in the use of its resources.

To arrive at our conclusion we looked at the Authority's arrangements to make informed decision making, sustainable resource deployment and working with partners and third parties.

High priority recommendations

We have not raised any high priority recommendations as a result of our 2017-18 work.

Certificate

We issued our certificate on 30 August 2018. The certificate confirms that we have concluded the audit for 2017-18 in accordance with the requirements of the Local Audit & Accountability Act 2014 and the Code of Audit Practice.


Audit fee

We have not identified any matters that would require us to issue a public interest report.




